## NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH - The North Carolina Alcoholic Beverage Control Commission held its regular monthly meeting on December 11, 2019 and ratified 62 hearing cases that resulted in penalties in excess of $\$ 74,400$ and/or imposition of suspensions of permits for three days or more. Fines are due January 3, 2020, and suspensions begin January 10, 2020.

The Commission approved a proposed new ABC store location on Hwy US 17 at the corner of North E Street and E. Bridge St., Bridgeton, requested by the Craven County ABC Board.

The Commission approved an exemption request pursuant to §18B-1116(b) for Craft Revolution, LLC; Southern Tier Brewing Company, LLC; Victory Brewing Company, LLC; Mad Scientists Brewing Partners LLC (add locations) and Artisanal Brewing Ventures Charlotte, LLC.

The Commission continued an additional exemption request pursuant to §18B1116(b) for Craft Revolution, LLC; Southern Tier Brewing Company, LLC; Victory Brewing Company, LLC; Mad Scientists Brewing Partners LLC; Artisanal Brewing Ventures Charlotte, LLC and Bold Rock Partners LP.

The Commission considered and adopted changes to Subchapter 15B, Section .1004 of the Commission's administrative rules regarding a Permanent Increase of the Maximum Retail Discount Rule. The rule will be filed with the Office of Administrative Hearings for approval by the Rules Review Commission and publication in the NC Administrative Code.
