**NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING**

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting in person on Wednesday, May 10<sup>th</sup>, 2023 and ratified 94 hearing cases that resulted in penalties in excess of \$112,800 and/or imposition of suspensions of permits for three days or more. Fines are due on or before June 2<sup>nd</sup>, 2023, and suspensions begin June 9<sup>th</sup>, 2023.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Michael Adams; Edge City Brewery, LLC; Elizabeth Pizza Pub, LLC; HC Hawthorne's, LLC; MH Hawthorne's, LLC; MP Hawthorne's, LLC; and NS Hawthorne's, LLC.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Chris Borrenson; BBBC, LLC T/A Wye Hill Kitchen and Brewing; 629 Group, LLC T/A Glasshouse Kitchen; and 629 Group, LLC T/A Twisted Ladder.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Tribeca Hospitality, LLC; VIM Holdings, LLC; Robert Frame; and Jeffrey Schenk.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Billy Dale Overbee, Blackbeard's Triple Play, LLC, and Triple Play Oasis Restaurant and Sports Bar.

The Commission approved an amended exemption request pursuant to [§18B-1116\(b\)](#) for Sumit Vohra; Lonerider Brewing Company; Hub at OKI, Inc.; Lonerider Spirits, LLC; and Lonerider Spirits-Durham, LLC.

The Commission approved a proposed ABC store location at 3055 Dale Earnhardt Boulevard, Lot 2, Kannapolis, as requested by the Concord ABC Board. This store will replace the Concord ABC store located at 2245 Spider Dr NE, Kannapolis.

The Commission approved a proposed ABC store location at 322 Oak Street, Highlands, as requested by the Highlands ABC Board. This store will replace the Highlands ABC store located at 81 Highlands Plaza, Highlands.

The Commission continued the request from LB&B Associates Inc. until the next Commission meeting.

The Commission agreed to allow temporary permits to be reinstated for 10 days only for Beach Road Bottle Shop in Kill Devil Hills so the applicant can complete the sale of the business with active permits.

The Commission confirmed the next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, June 14<sup>th</sup>, 2023 at 10:00 am.
