**NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING**

RALEIGH – The North Carolina Alcoholic Beverage Control Commission held its regular monthly meeting on November 13, 2019 and ratified 91 hearing cases that resulted in penalties in excess of \$109,200 and/or imposition of suspensions of permits for three days or more. Fines are due December 6, 2019, and suspensions begin December 13, 2019.

The Commission approved a proposed new ABC store location at 3318 Brookridge Lane, High Point, requested by the High Point ABC Board.

The Commission approved a proposed new ABC store location at 10 Blake Blvd, Pinehurst, requested by the Moore County ABC Board.

The Commission approved a proposed new ABC store location at NC 97 and South Halifax Rd, Rocky Mount, requested by the Nash County ABC Board.

The Commission approved an exemption request pursuant to §18B-1116(b) for John Kelly; Stephen Pye; Seaboard Brewing Company, LLC; and Zilla Ventures LLC.

The Commission continued an exemption request pursuant to §18B-1116(b) for Matthew Ganzert; Cold Craft Beverage Partners LLC, BM Cary LLC d/b/a Highcraft Beer Market; and HC Cary LLC d/b/a Amberly Local.

The Commission held a public hearing on proposed Permanent Increase Maximum Retail Discount Rule – 14B NCAC 15B.1004.

The Commission reconsidered and withdrew from consideration the change to Subchapter 15A, Section .1101 of the Commission's Administrative Code regarding Local Board Operations Rules.
