NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, July 10th, 2024, and ratified 106 hearing cases that resulted in penalties in excess of \$126,300 and/or imposition of suspensions of permits for three days or more. Fines are due on or before August 2nd, 2024, and suspensions begin August 9th, 2024.

The Commission amended a Final Agency Decision for Southerlands Cigar Lounge.

The Commission denied a hardship waiver request for YaYa Mini Mart.

The Commission approved an exemption request pursuant to §18B-1116(b) for Littleton Brewing Company, LLC T/A Timber Waters Brewing Company; Bluejay Industries, LLC T/A Blue Jay Bistro; Bluejay Industries, LLC T/A Main Street Mercantile; Edward P. Fitts, Jr.; and Debra Lynn Fitts.

The Commission continued an exemption request pursuant to §18B-1116(b) for The Olde Mecklenburg Brewery LLC T/A The Olde Mecklenburg Brewery; OMB Ballantyne LLC T/A The Olde Mecklenburg Brewery; and John Marrino until a future meeting.

The Commission approved a proposed ABC store location at 4407 Burlington Road, Greensboro, as requested by the Greensboro ABC Board.

The Commission approved a proposed ABC store location at 6755 NC-46, Garysburg, as requested by the Northampton County ABC Board.

The Commission approved a proposed ABC store location at 65 Ramseur Road, Suite #110, Pittsboro, as requested by the Pittsboro ABC Board.

The Commission approved a proposed ABC store location at 501 South Main Street, King, as requested by the Stokes Municipal ABC Board.

The Commission ratified that two rules, 14B NCAC <u>15A</u>.1801 and <u>15A</u>.2104, are no longer necessary due to the repeal of the Purchase Transportation Permit. The Commission ratified that all other rules in <u>Subchapter A</u> are necessary. These decisions are part of the Commission's initial determination for the mandatory rules review pursuant to <u>§150B-21.3A</u>. There will be a 60-day comment period expiring on September 17th.

The Commission moved into a closed session with legal counsel to discuss a proposed mediation settlement related to LB&B v. DPS and ABCC, pursuant to §143-318.11.

The Commission moved the October 2024 Commission meeting date to October 16th, 2024.

The Commission also confirmed the next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, August 14th, 2024, at 10:00 am.
