NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, March 13th, 2024, and ratified 82 hearing cases that resulted in penalties in excess of \$98,400 and/or imposition of suspensions of permits for three days or more. Fines are due on or before April 5th, 2024, and suspensions begin April 12th, 2024.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Deep River Brewing Company, LLC; Fare Game, LLC; and Paul Auclair.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Nine Mile, Inc.; The Trailhead Restaurant, Inc.; Aaron Thomas; and Paige Knoll.

The Commission continued the exemption request for Suffolk Punch Holdings, LLC; Noble Smoke, LLC; Bossy Beaut's Chicken Shack II, LLC; Bossy Beaut's Chicken Shack 3, LLC; Charles Ricks; and Glen Cherry until a future Commission meeting.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Weeping Radish Brewery LLC; Firetender Manteo, LLC; Sumit Gupta; and Amit Gupta.

The Commission approved a proposed ABC store location at 1270 Charlotte Highway, Mooresville, as requested by the Troutman ABC Board.

The Commission denied a request pursuant to [§18B-704](#) from Greg Tharrington due to lack of jurisdiction.

The Commission moved into a closed session with legal counsel to discuss a proposed mediation settlement pursuant to [§143-318.11](#).

The Commission approved July 10th, August 14th, September 18th, October 9th, November 6th, and December 11th of 2024 as future meeting dates.

The Commission also confirmed the next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, April 10th, 2024, at 9:00 am, which is an hour earlier than usual.
