### NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, October 16<sup>th</sup>, 2024, and ratified 85 hearing cases that resulted in penalties in excess of \$102,000 and/or imposition of suspensions of permits for three days or more. Fines are due on or before November 8<sup>th</sup>, 2024, and suspensions begin November 15<sup>th</sup>, 2024.

The Commission approved an amended exemption request pursuant to [§18B-1116\(b\)](#) for DNA Beverage Company, LLC T/A Nomad Wine Works, The Brewer's Kettle, LLC T/A The Brewer's Kettle, The Brewer's Kettle at 313, David Armstrong, and William A. Sizemore.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Storm Clouds Brewing, LLC T/A Clouds Brewing, Clouds Brewing LLC, and Matthew MacNeil.

The Commission approved a technical change to the amended exemption request pursuant to [§18B-1116\(b\)](#) for Suffolk Punch Holdings, LLC; which was approved at the September 2024 Commission meeting.

The Commission moved into a closed session with legal counsel to discuss a confidential personnel matter, pursuant to [§143-318.11](#).

The Commission confirmed the next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, November 13<sup>th</sup>, 2024, at 10:00 am.
