NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting on Wednesday, September 18th, 2024, and ratified 76 hearing cases that resulted in penalties in excess of \$89,100 and/or imposition of suspensions of permits for three days or more. Fines are due on or before October 11th, 2024, and suspensions begin October 18th, 2024.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Oklawaha Brewing Company, LLC and Blue Ridge Beer Garden, LLC, and Joseph Dinan.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for Monday Night Ventures, LLC, T/A Monday Night Ventures (GA) and Monday Night Ventures, LLC, T/A Monday Night Brewing (NC).

The Commission approved an amended exemption request pursuant to [§18B-1116\(b\)](#) for Suffolk Punch Holdings, LLC; Noble Smoke, LLC; Bossy Beaut's Chicken Shack II, LLC; Bossy Beaut's Chicken Shack, LLC; Harriet's Hamburgers BB, LLC; Glen D. Cherry, and Charles C. Ricks.

The Commission approved a motion to enter into the minutes the terms of the settlement between LB&B Associates Inc. and the NC Department of Public Safety and the NC ABC Commission (23 CVS 11378-910).

The Commission moved into a closed session with legal counsel to discuss a confidential personnel matter, pursuant to [§143-318.11](#).

The Commission moved the November 2024 Commission meeting date to November 13th, 2024, and approved January 15th, February 12th, and March 12th of 2025 as future Commission meeting dates.

The next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, October 16th, 2024, at 10:00 am.
