### NORTH CAROLINA ABC COMMISSION HOLDS REGULAR MEETING

RALEIGH – The North Carolina Alcoholic Beverage Control (ABC) Commission held its regular monthly meeting in person on Tuesday, September 12<sup>th</sup>, 2023, and ratified 116 hearing cases that resulted in penalties in excess of \$139,200 and/or imposition of suspensions of permits for three days or more. Fines are due on or before October 6<sup>th</sup>, 2023, and suspensions begin October 13<sup>th</sup>, 2023.

The Commission approved an exemption request pursuant to [§18B-1116\(b\)](#) for O'Grady Public House, LLC T/A Finnigan's Wake; Roller Mills, LLC T/A Hoots Beer Company; and Brian Cole.

The Commission approved an employee exemption request pursuant to [§18B-201\(a\)](#) for Kim Bradley.

The Commission continued consideration of the Order for Return of Evidence Seized in ABC Case #27076-RN until the next Commission meeting.

The Commission approved a proposed ABC store location at 3371 Springs Road NE, Hickory, as requested by the Catawba County ABC Board. This store will replace the Catawba County ABC store located at 2517 Springs Rd NE, Hickory.

The Commission approved a proposed ABC store location at 1214 Redbourne Road, Greensboro, as requested by the Greensboro ABC Board. This store will replace the Greensboro ABC store located at 2309 Flemming Rd, Greensboro.

The Commission approved a proposed ABC store location at 212 South Salisbury Street, Raleigh, as requested by the Wake County ABC Board.

The Commission moved into closed session with legal counsel to discuss a Complaint for Declaratory Judgment.

The Commission confirmed the next monthly meeting will be held at the NC ABC Commission (400 E Tryon Road, Raleigh, NC 27610) on Wednesday, October 11<sup>th</sup>, 2023 at 10:00 am.
