

ALCOHOLIC BEVERAGE CONTROL COMMISSION

HOW TO APPLY FOR A COMMERCIAL TRANSPORTATION PERMIT

The Commercial Transportation permit applies to vehicles transporting alcoholic beverages (beer/wine/spirituous liquor) on the roads of North Carolina and traveling out of the state or bringing products into North Carolina. If transporting spirituous liquor, a \$1,000 surety bond is required. Upon receipt of the completed bond form and the application, the temporary permit which will be emailed. The permanent permit will be sent via U.S. mail. The original is to be kept in your files and certified copies placed in any vehicle coming into North Carolina. Upon receipt of the permit, the permittee can begin transporting alcoholic beverages.

If transporting beer/wine, no bond is required.
